## INFORMATION & REPORTS –

### A. Outdoor Discovery Center Field Trip

Mrs. Zender and Ms. Dykhouse thanked the Board for providing funding for the recent field trip to Outdoor Discovery Center, which benefited 155 fifth-grade and 150 fourthgrade students. The financial support, including transportation costs, made the experience possible with no cost to our families. The trip provided meaningful, handson learning experiences that extended classroom instruction and sparked a genuine interest in nature and environmental science. Fifth-grade students explored wetlands in small groups, observing firsthand how Earth's systems interact. Fourth-grade students experienced science standards related to animals, their structures, and survival needs. Students were able to observe and even touch various animals, enhancing their understanding through direct interaction. The event was well supported by parent chaperones, and several of the instructors were retired teachers who provided valuable educational guidance. They also ended the trip going to Lake Michigan. Many students had never seen Lake Michigan before, making the trip a memorable experience. Overall, the field trip fostered student engagement, strengthened interest in science, and created meaningful connections among students. Appreciation was expressed to the Board for enabling such a successful and impactful learning opportunity.

## B. Elementary Parent-Teacher Conferences

Mr. Muhammad and Mrs. Wass presented highlights on parent participation at the elementary level for the fall parent-teacher conferences held on October 2 & 8. Participation data for each building was as follows: Southeast Elementary: 87.98% of families participated in-person. The remaining families engaged through phone conferences or received progress reports, resulting in a 100% overall parent connection rate. West Elementary: 98.00% attended in person, with the remaining 31 families connected via progress reports or phone conferences, achieving 100% parent contact. Central Elementary: 98.16% attended in person, with the remaining 54 families contacted through progress reports, emails, or phone calls, achieving 100% parent contact as well. Overall, participation rates showed a slight increase compared to

previous years. Parents were able to schedule conferences through the Synergy platform for the first time, and many families are using this tool successfully.

## C. Elementary School Improvement Plans

Mrs. Wass presented the Southeast school improvement goals for the upcoming year. Students will take the NWEA assessments in the fall, winter, and spring. The reading goal is for 70% of students to meet or exceed their projected growth from fall 2025 to spring 2026; last year, 62% met this target. The math goal is for 75% of students to meet or exceed their projected growth. For the whole-child (SEL) goal, the aim is for all students to show an increase in their SEL scores from fall to spring. Instructional supports include Bookworm for grades K-2, IRP, and daily literacy activities. In math, the curriculum includes Math Expressions, with intervention provided for students performing in the lower range. SEL instruction will occur weekly. Mrs. Wass also noted that it typically takes 2–4 years for English Language Learners (ELL) who arrive from another country to test out of the program. For West, the goals mirror Southeast: 70% of students meeting or exceeding projected growth in reading; 62% met the goal last year. The math goal is 75%, and SEL growth for all students. The ELL program aims for a 10% exit rate. Instructional supports are the same as those used at Southeast. For Central, Mr. Muhammad shared the goals are for 50% of students to meet or exceed projected growth in both reading and math, with SEL scores increasing for all students. Supports include daily read-alouds, Bookworms, and small-group reading instruction as needed. Math instruction utilizes EnVision Math, problem-based learning, and smallgroup lessons using Bridges. SEL instruction includes Second Step lessons delivered by the counselor, along with PBIS and SOAR initiatives. ELL students receive direct language instruction, with newcomers receiving additional small-group or one-on-one support. WIDA scores have shown strong performance recently, and the school continues to recognize and celebrate students who exit the ELL program.

 Cameron Clark – shared that all of the field trips supported by the Board provide great opportunities and create lasting memories for students. He also mentioned that band auditions for the Washington D.C. trip will take place next week and expressed his excitement about participating. He expects to learn soon whether he has been selected.

  interest for years to come. She thanked Ms. Kleyn for her dedication and hard work.
- Mr. Flores-Garcia thanked and congratulated Ms. Kleyn on her certification. He
  also remarked that he had attended this field trip with his son last year and found it
  be a wonderful experience, noting how much the students enjoyed it how it creates
  lasting memories;
- Mrs. Ward echoed previous comments, expressing appreciation for Mrs. Kleyn for her contributions. She also congratulated Ms. Groters, noting that her recognition reflects the strength of her communication efforts. She added that she is very supportive of the field trips and values the experiences they provide for our students.
