A. Report: Close Up

Close Up Advisors Mr. Salminen, Ms. Gardiner and a student who attended Close Up this year shared information about their recent visit to Washington D.C. The trip allowed the students to not only see the government but also experience it in action. They went

to several museums and were divided into groups with other districts across the country, where they had workshops every day. They learned how to have a voice as a young adult, how to debate in a respectful manner and had a mock congress workshop. This opportunity allowed the students to see new places, meet new friends, and have an amazing experience that they will never forget, thanking the Board for their support.

B. NWEA Rewards

Mr. Morrow provided an overview of the recent NWEA Rewards trip to Celebration Cinema. A total of 154 students qualified for the trip by achieving personal best benchmarks, improving their scores from fall to spring in at least two out of the three NWEA assessments. Prior to testing, students were invited to share ideas for a potential reward if they met their goals. The cinema trip was selected based on their feedback. By encouraging students to strive for their personal best, many achieved a years' worth of academic growth. Participation and effort were notably higher than traditionally, and they students thoroughly enjoyed the trip. Mr. Morrow expressed a desire to continue offering similar incentives in future years and extended his appreciation to the Board for their support in making this initiative possible.

SUPERINTENDENT EVALUATION

The Board conducted their annual Superintendent Evaluation for Mr. Alston per the Revised School Code requirement, to evaluate his performance as part of the comprehensive performance evaluation system using the MASB provided tool. It takes into account Board/Staff/Community Relations, Business & Finance, Instructional Leadership and Student Growth Data. Based on the scores provided, Mr. Alston's summative evaluation score indicated a rating of "Highly Effective" for the 2024-25 school year.
